RESOLVED that the Town Board does hereby adopt the following legislation:

LOCAL LAW NO. 13-2012 TO AMEND  
CHAPTER 117-1 OF THE TOWN CODE

BE IT RESOLVED, that the Town of Bedford Amends Chapter 117, Article I, Section 1 of the Code of the Town of Bedford regarding Parking and Traffic Regulations as follows:

Section 1. Chapter 117, Article I, Section 1(C), regarding Parking in Katonah is hereby amended to further restrict parking on The Terrace in Katonah, as follows:

§ 117-1. Enumeration of restrictions and restricted areas.

Parking or standing of vehicles within and upon the hereinafter designated streets, public places and portions thereof shall be restricted and/or regulated as follows:
