- Provide a copy of each vehicle's registration. Only cars owned and registered to the resident may be listed on the permit.
- Proof of residency (copy of a utility bill, front page of closing document or lease agreement). Tax bill and driver's license are not acceptable for proof of residency. If you rent or live at home with your parents, copy of the car insurance policy will suffice for residency.
- Please provide a self addressed, stamped envelope.
- The fee for a full year is \$475 or \$425 if a hybrid or electric vehicle is listed on the permit.
- Current prorated amount for the permit is _____ or _____ with a hybrid/electric listed.
