**FIRE ALARMS**- In order to ensure a timely response for fire alarms please advise your alarm company that a fire alarm should be called into the following fire department numbers: **Bedford Hills- (914)666-4079, Katonah- (914) 232-3000, and Bedford Village (914)234-3321.**

**IF YOU HAVE A PANIC ALARM SYSTEM**: In order to ensure the safe being of the persons or property within the described building, I authorize the Town of Bedford Police Department to effect an entry to said building by any means necessary.
